



**BIODIVERSITY** ● Challenged Bush administration rollbacks to **Endangered Species Act** cutting science from decisions affecting imperiled species ● Furthered sweeping legal campaign to overturn politically tainted decisions under Bush that slashed protections for dozens of endangered species, and secured agreement to redo critical habitat designations for **19 species** ● Halted stocking of hatchery trout in California waters where sensitive **native fish and amphibians** are present ● Petitioned for Endangered Species Act protection for 32 species of Pacific Northwest **mollusks** after Bush administration axed forest protections in their habitat ● Fought Bush attempts to remove federal protections for – and allow increased gunning down of – **Rocky Mountains gray wolves** ● Filed suit to compel federal protections for **jaguar** habitat and recovery plan for species, in light of increased threats from new U.S.–Mexico border wall ● Called upon federal government to strengthen protections for imperiled **bat** species due to widespread die-off in U.S. Northeast, in connection with mysterious “white-nose syndrome”

**CLIMATE** ● Secured “threatened” listing for **polar bears** under Endangered Species Act, forcing Bush administration to significantly acknowledge global warming on world stage ● As result of Center lawsuit, compelled Bush administration’s release of long-overdue scientific assessment of climate change impacts in U.S. ● Prompted, through court order, Bush administration proposal to improve lax national fuel economy standards for passenger vehicles ● Petitioned to protect **Pacific walrus** under Endangered Species Act due to threats from global warming and oil and gas development ● Petitioned to protect **ringed, bearded, and spotted seals** under Endangered Species Act due to warming-caused Arctic sea-ice melt ● Secured proposal to protect seven species of **penguins** under Endangered Species Act ● Filed suit challenging Bush administration plan to sell off prime polar bear habitat in **Alaska’s Chukchi Sea** for oil and gas development ● Won court ruling, in California Environmental Quality Act case, affirming that developers must consider greenhouse gas emissions in land-use planning

**OCEANS** ● Won Endangered Species Act protection for **Cook Inlet beluga whale** after 10-year battle ● Gained protection for **North Pacific right whale** under the Endangered Species Act as species distinct from North Atlantic right whale, and compelled designation of 36,750 square miles of critical habitat ● Secured nearly 3,000 square miles of critical habitat for **elkhorn** and **staghorn corals** off coasts of Florida, Puerto Rico, and U.S. Virgin Islands ● Furthered campaign to compel Environmental Protection Agency and coastal states to address ocean acidification under Clean Water Act ● Won U.S. 9th Circuit Court of Appeals ruling halting Shell Oil exploration in **Beaufort Sea** after Bush administration rushed through permits without considering effects on **bowhead whale** and other Arctic life ● Halted U.S. Navy’s Undersea Warfare Exercises in Hawai’i’s waters pending additional measures to protect **marine mammals** from high-intensity sonar ● Petitioned to expand protected critical habitat for endangered **Hawaiian monk seals**, as global warming drives seals from threatened habitat on remote islands to coastal areas along more populated main islands

**PUBLIC LANDS** ● Won court order halting new uranium development adjacent to **Grand Canyon** National Park, spurring Congressional resolution and new legislation to shield Grand Canyon watersheds from new uranium development ● Blocked motorized crossings on lower **San Pedro River**, in world-renowned wildlife corridor, on land set aside for protecting **southwestern willow flycatcher** ● Mounted aggressive legal campaign to protect public lands and endangered species from new coal-fired power plants, coal leases, and oil shale and gas development in seven western states ● Stopped deadly project relocating **Mojave Desert tortoises** to make way for military-base expansion, and fought government attempts to severely weaken tortoises' recovery plan ● Successfully challenged Bush rule opening **Sierra Nevada's national forests** to more logging, and challenged administration's attempts to weaken wildlife protections across entire national forest system ● Ousted Sunrise Powerlink power line in Southern California from sensitive wildlands including **Anza-Borrego State Park**

**URBAN WILDLANDS** ● Blocked 2,600-acre sprawl development in San Diego-area habitat for threatened **California gnatcatcher** and endangered **Quino checkerspot butterfly**, winning lawsuit over public health and environmental concerns ● In landmark case, successfully challenged proposed resort near **Joshua Tree National Park** for failure to analyze project's greenhouse gas emissions ● Won court victory striking down approval for sprawl development on remote, undeveloped grasslands and chaparral at base of Southern California's **San Bernardino Mountains** ● Won appeals court ruling upholding strike-down of approval for controversial mountain subdivision at **Lake Arrowhead** in fire-prone forest wildland area ● Overturned approval for open-air sewage sludge compost facility in Hinkley, rural California town made famous for landmark water-contamination case depicted in *Erin Brockovich* ● Called for restoration of Pacifica's Sharp Park golf course to natural coastal wetland, initiating legal challenge against San Francisco for killing threatened **California red-legged frogs** and threatening endangered **San Francisco garter snakes**

**INTERNATIONAL** ● Under International Bird Initiative, secured U.S. Endangered Species Act listings for six of world's rarest birds: **black stilt** (New Zealand), **caerulean paradise-flycatcher** (Indonesia), **giant ibis** (Laos, Cambodia), **Gurney's pitta** (Burma, Thailand), **long-legged thicketbird** (Fiji), and **Socorro mockingbird** (Mexico) ● Won proposed protection for five rare Latin America native birds: **black-breasted puffleg**, **medium tree finch**, **Andean flamingo**, **Chilean woodstar**, and **St. Lucia forest thrush** ● Supported Ngobe people's fight before Inter-American Commission on Human Rights to block massive hydroelectric dam project, by U.S. utility AES, that threatens **La Amistad Biosphere Reserve**, World Heritage site shared by Panama and Costa Rica ● Assisted local activists in challenging questionable "eco"-development at Panama's Red Frog Beach ● Won court ruling finding U.S. Department of Defense in violation of National Historic Preservation Act and requiring it to consider impacts of new airbase on Japan's endangered **Okinawa dugong** ● Surpassed 200,000 downloads from *RareEarhtones.org*, in more than 150 countries around globe, of rare and endangered species ringtones

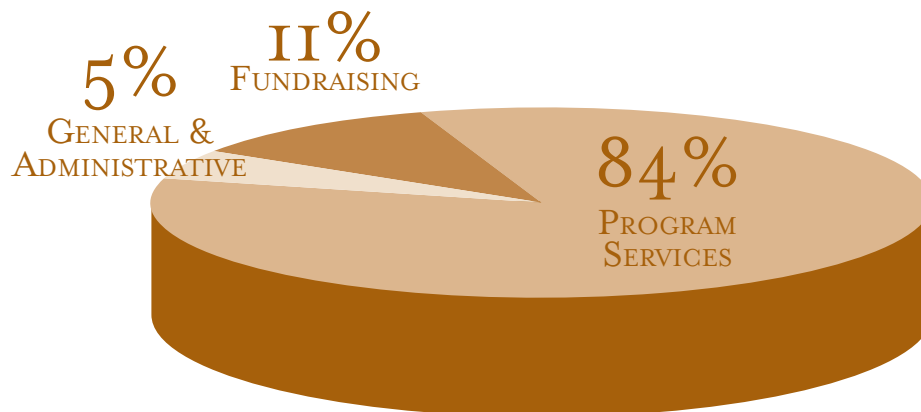

Despite the flagging economy in 2008, the Center's supporters contributed close to \$8 million to our critical efforts to protect imperiled wildlife and habitat.
